Call to Order:

President Chet Thayer called the meeting to order at 7:35 P.M.

Reading of the Minutes:

Mike Hunter summarized the meeting minutes from September. Chet Thayer noted one correction in that he was nominated for president at the September meeting. The meeting minutes were accepted as summarized and corrected.

COMMITTEE Reports:

- Treasury Report: Elliot Smith reported that we have \$xx.xx in our accounts with no outstanding bills. Expenditures during the most recent period were for the Porta-John and the picnic. Elliot will be sending out 2011 Dues invoices the 1st of November payable by November 30th.
- **Safety Report:** There was no safety report. However, there was discussion about the flying of helicopters and fix wing aircraft at the same time. Since at our last meeting it was noted that some of our traditional flying rules (like only four aircraft at one time) were not documented Mike Hunter agreed to form a committee to review our current by-laws and to update them to document our current and possible new flying rules.
- **Field Report:** There was no field report. However, Ron Becker did discuss setting up a fall field day where we might cut down trees and clear brush from various parts of the field. However, the day should be scheduled after the fall moto-cross race so that we can address any clean-up required by that race.

OLD Business

<u>Club Trainers:</u> Joe Berry reported that the plan of setting up a permanent charge of our trainers would not be advisable with the charger he planned to use as its charge rate was too high. Additionally, the cost of a

charger that would work was prohibitive. As a result, Larry Nolan will set up two banana plug adapters inside the shed where the trainers and radios can be charged without having to move the planes. It takes only about 20 minutes to charge the transmitter and planes.

- New Safety Benches: There was no activity to report on building the three new safety benches approved at September's meeting.
- Gift Certificate: Joe Berry reported that he has no gotten a gift certificate as yet.
- **2011 Officer Nominations:** One more nomination was made at the meeting for vice-president. The elections will take place the November meeting. Additional nominations will be accepted up until the vote is taken. The current nominees for 2011 officers are:

OCTOBER'S MYSTERY AIRCRAFT



Rutan Quickie

The **Quickie** is a light single seat homebuilt aircraft designed by Burt Rutan and Tom Jewett. One of the dozens of unconventional aircraft penned by Rutan for the general aviation market, the original Quickie is Model 54 in Rutan's design series.

The Q2 is a two seater version in kit form designed by Canadian Garry LeGare and the founders of the Quickie Aircraft Corporation Tom Jewett, and Gene Sheehan. Over 2000 kits were sold before production ended.

Appearing at first glance to be a modified biplane or canard design, the Quickie is a tandem wing aircraft; both the front and rear wings are full airfoils. The forward wing is technically a canard, fitted with elevators, but it provides about 60% of the lift. The aft wing serves as horizontal tail, although all pitch control comes from the forward canard. Highly efficient, and of composite construction, the Quickie and Q2 are typical Rutan aircraft designs.

Development

The Quickie was designed in 1977 by Burt Rutan, with the prototype construction commenced in August of that year. The design was frozen in January 1978.

The design of the Quickie was optimized to be a minimal number of fiberglass components: the fuselage/fin, front wing and rear wing. Integration of components was a high priority, and the engine choices very wide. The original design called for a Onan 18HP engine, the prototype used a Volkswagen air cooled engine.

Rutan later stated that the design was meant to echo the X-Wing of Star Wars, making the Quickie an attractive and an exciting aircraft for a first-time homebuilder. He stated the dual-wing with a single rudder layout was not new, and had been used in the past in aircraft such as the Flying Flea.

Kit production commenced in June 1978 and by the late 1990s over 3,000 single and two seater kits had been produced and sold.

Quickie


The original model has one seat and is powered by an 18 horsepower (14 kW) engine

Ouickie O2

This two seater has a 64 horsepower (48 kW) Volkswagen engine and can be constructed as a Tri-Q with tricycle rather than conventional landing gear.[citation needed]

O200

This two seater model is faster than the Q2 with a 105 horsepower (78 kW) Continental O-200 engine and uses a different airfoil for the canard. It can also be constructed as a Tri-Q with tricycle rather than conventional landing gear.[citation needed]



ARTICLE 3: ELECTIONS AND TERMS OF OFFICE

- 1. All elected officers of the Club shall serve for one (1) year from date of election. Officers are to be elected by a vote of simple majority of those present at the regular meeting in the month of November. Mail-in ballots will be made available for those members who have voting rights but cannot attend the meeting. Those ballots, returned by mail before the November meeting, will be counted as if those persons were present at the meeting. New officers will take office immediately after the November meeting. Personnel will be appointed by the elected officers and confirmed by a simple majority vote of those members present during a regular meeting: i.e. Newsletter Editor, Contest Director, etc.
- 2. Nomination of Club officers shall be made at the general membership meeting during the month of October. Nominations for office may be made by any active Club member holding voting rights, either in person or by submitting a proxy nomination to an existing officer. All known nominations for office will be published in the newsletter prior to the election.
- 3. A secret ballot is required for elections, for removal of a Club officer, a member of the Board of Directors, and for expulsion of a member from the Club unless waived by a simple majority vote of the members present at the meeting.

- 3. Dues are \$60.00 per year for A.M.A. Open members and \$25.00 for A.M.A. Youth members (those not 19 by July 1). Members age 65 or older by July 1 will be assessed \$35.00. No dues are assessed for Junior members when a parent or guardian holds an Open Club membership.
- 4. All dues are payable in advance by **November** 30 of each year. Members who do not pay their dues by December 31 will be listed in the January newsletter. Any members who do not pay their dues by January 31 will be dropped from the Club membership.
- 5 Dues for new members joining prior to September 1 will be for the full year amount. Dues for members joining after September 1 will be prorated at \$6.00 per month for each month remaining in that year.
- 6. Members dropped from the Club for non-payment of dues may be reinstated after paying the annual dues plus the \$10.00 late fee.
